Abstract

Honesty in today's era is increasingly apprehensive. Acts of cheating, violating traffic rules, corrupt behavior, are some of the actions that occur because of the loss of the value of honesty. Lying is an ordinary behavior. This research aims to form honest character through Pancasila Education and Citizenship Education. This Pancasila Education and Citizenship Education course is one of the courses that emphasizes honest behavior. The research was conducted in the agrotechnology class of the North Padang Lawas Institute of Technology and Science with qualitative methods. Data collection techniques using direct observation, interviews with lecturers and students, documentation in the form of pictures, and literacy based on relevant scientific articles. Abstrak

1.
